Voluntary Government-Business Partnership

- Industry Plays an Active Role in Securing the Supply Chain
- Government Officials Work Directly with Industry to Enhance Security

Benefits to Carriers

- Reduced Inspections at Borders
- Priority Processing for Inspections (Front of Line Privileges)
- Access to FAST (Free and Secure Trade) Lanes

Issues

- One Strike and You're Out
- Carriers Removed from Program Immediately Pending Investigation
- Exposure of Large Carriers vs. Smaller Carriers
- Single Incident vs. Systemic Security Problem

FAST PROGRAM

Expedited FAST Lanes at Land Borders

- C-TPAT Members Have Access to FAST Lanes
- Drivers Undergo a Thorough Background Check for FAST Privileges

Benefits to Carriers

- Expedited Clearance if Transporting for C-TPAT Importers
- Reduces Duration of Border Crossings

Issues

- Current Infrastructure Inhibits True “FAST Lanes”
- C-TPAT Carriers Wait in Traffic with Non-C-TPAT Carriers



Cross-Border Security Initiatives

ACE Program

Electronic Manifest System

- Captures Trade Data
- Clears Cargo Entering the U.S.
- Enables CBP to Target High Risk Cargo

Benefits to Carriers

- Reduces Paper Crossing Documents
- Eliminates Need For Brokers
- Reduces Duration of Border Crossings

Issues

- Information Sharing between Agencies Requires Multiple Entries
- Standardization between Agencies will Increase Efficiency, Reduce Crossing Times and Improve Security



Cross-Border Security Initiatives

Driver Identification/Endorsements

- Land Borders - FAST Cards
- Ports - Transportation Worker Identification Credential (TWIC) and Individual Port Identification Cards
- Military Freight - DOD Identification Card
- Hazardous Materials - HAZMAT Endorsement
- International Freight - Passports

Benefits to Carriers

- Necessary for Specific Applications

Issues

- Repetitive Background Checks, Databases, and Expenses
- Harmonize Identification Cards to Improve Security and Reduce Strain on Drivers, Carriers and Shippers
