INTRODUCTION TO GLACIER & GLACIER TAX PREP

ISS is pleased to announce that Purdue's international students, faculty and staff at the West Lafayette campus will have access to the tax software program, GLACIER TAX PREP. This free program can provide step-by-step assistance with nonresident alien income tax form preparation.

GLACIER

Glacier is an online tax compliance system that allows institutions to efficiently and effectively collect information, make tax residency and income tax treaty determinations, maintain data, and file reporting statements with the IRS. Purdue University uses Glacier to make sure we pay and tax our international population correctly.

All students and scholars that have been paid by Purdue University (employment, fellowships, scholarships, awards, etc.) should have a Glacier account. For those paid by Purdue, you can access Glacier Tax Prep directly directly through your Glacier account. Your Glacier information will be transferred directly into Glacier Tax Prep, making it easier for your to file your tax return paperwork.

You DO NOT need to request access to Glacier Tax Prep through myISS if you already have a Glacier account.

GLACIER TAX PREP (GTP)

Glacier Tax Prep provides federal tax filing assistance for nonresident aliens. Glacier Tax Prep will:

- Determine U.S. Tax Residency Status
- Determine the Person's U.S. Tax Return Filing Requirement
- Collect Additional Information
- Finalize Tax Return and Forms

International students and scholars at Purdue can access Glacier Tax Prep for free. You will either log into Glacier Tax Prep through your Glacier account, or request access through myISS.

- Click the Glacier Tax Preparation link.
- Review the information on the page, then click the Access Glacier Tax Prep button.

- Go to myISS at connect.iss.purdue.edu
- Scroll to the bottom of the page where it says "**Don't Have a Purdue Career Account?**" and click the **Student/Scholar Login** button.
- Click the E-mail me my Limited Access PIN button at the bottom of the screen if this is your first time. Enter your Purdue University ID number and click Submit. NOTE: Omit the first zero when entering your Purdue ID number in the University Identification Number. If your PUID is 0012345678, enter 012345678. An email will be sent to the email address that you last reported to ISS.
- Once you receive the Limited Access PIN in the email, use it to log in to Limited Services by entering the following:
 - Your Purdue University ID number. NOTE: Omit the first zero when entering your Purdue ID number in the University Identification Number area. If your PUID is 0012345678, enter 012345678.
 - Your Date of Birth
 - Your Limited Access PIN
