Re: Approval of Amended 2019-20 Student Housing Rates for Purdue Fort Wayne

At its December 7, 2018 meeting, the Board approved 2019-20 housing rates, including rates for Purdue Fort Wayne (PFW). PFW proposes a slight amendment to those rates as described below and on the attached Housing Rate table.

On-campus housing at PFW is comprised of one, two, three, and four bedroom apartment-style configurations. At the time of the December 7, 2018 Board of Trustees meeting, PFW projected a re-configuration that would yield 1,172 beds for on-campus housing.

With projected increases in first-time, full-time students entering in the fall 2019, PFW is currently 103% overbooked in Student Housing. It forecasts a 105% overbooked rate by the end of June 2019 and expects further increases throughout July and into early August.

While PFW is exploring additional, off-campus opportunities for overflow, which will employ the existing rate schedule, it does not want to turn away students who desire to live on campus. It believes that on-campus living is better for student success, retention, and engagement purposes. Thus, it proposes a room re-configuration that will yield more rooms at a lower per-student cost.

The proposed re-configuration will yield up to 64 more beds based on double occupancy of those units of the two bedroom/two bathroom deluxe units. Thus, the per-student/per-academic year cost for the reconfigured room would drop from \$8,300 to \$5,420.

If additional beds are needed, PFW proposes a similar re-configuration to permit double occupancy of its standard two bedroom/two bathroom units. This re-configuration would decrease the rate from \$6,641 per student/per academic year to \$4,316 per student/per academic year for those units and yield up to 144 more beds.
