Sponsor-owned equipment refers to tangible property purchased with federal grant funds where **title remains with the sponsor** (i.e., the federal government or pass-through entity), unless explicitly transferred to the recipient.

NOTE: At the end of the project, the equipment **may be required to be returned to the sponsor**, depending on the terms of the award and federal regulations.
