



Looking to the Future of HHS

How can HHS preserve our strengths through the COVID-19 pandemic? COVID-19 will change everything we do.

- Responding to necessary budget reductions
- Moving courses as possible into hybrid form so we are ready for residential education with less density in classrooms or to move online again if necessary
- Prioritizing moving as many HHS introductory courses into online/hybrid form
- Developing an HHS exploratory program of hybrid courses as a gateway to multiple HHS majors
- Developing exciting, interdisciplinary courses on the COVID-19 pandemic at the undergraduate and graduate level
- Maintaining our excellent clinical, professional education
- Ramping up research programs, looking carefully at social distancing in labs
- Doing everything we can to maintain our high challenge, high support, high touch approach to educating our students

Budget Reductions

Purdue University must make difficult decisions to remain a financially viable organization. Here is what we know so far.

- An overriding goal is to take the best possible care of the people we have and to minimize effects on full-time, benefits eligible staff and faculty.
- Hiring of staff and faculty are frozen.
- All merit increases have been paused.
- Most repair and rehabilitation projects are being delayed.
- Travel will be reduced.
- Purchasing will be reduced.
- Expenditures on overtime, temporary employees, and student employees will be reduced.
- Use of limited term lecturers will be reduced.

How will we maintain what is distinctive about HHS?

- Focus on improving health and quality of lives
- Excellent educational programs – preparing scientists and practitioners
- Groundbreaking research to improve human lives
- High challenge, high touch, high support of students – excellent academic advising, welcoming of students who change majors, clinical and professional education in clinics, practica, internships
