



INDIANA STATE FAIR

EMPLOYEE PARKING GUIDELINES

Again this year, we are asking all Indiana State Fair employees, volunteers, vendors and sponsors to park their vehicles in the employee parking lot on 46th Street. This lot is located just north of the Indiana School for the Deaf and is accessible from 46th street. The employee lot was created so that more parking can be offered to our Fair guests. We appreciate every employee's cooperation and understanding in this effort to better serve our customers. GETTING TO THE LOT

The employee lot is located on 46th Street, north of the Fairgrounds. 46th Street is a major artery that is easily accessible from College Ave. to the west and Keystone Ave. to the east.

From Keystone, turn west on 46th Street and travel approximately 3/4 of a mile to the employee lot entrance. From College, turn east on 46th Street and travel approximately 1/4 of a mile to the employee lot entrance.

The entrance will be clearly marked from 46th Street. Once inside, parking lot attendants will direct you the area designated for employees.

SAFETY AND SECURITY

The lot will be patrolled by a uniformed police officer 24 hours a day beginning July 29th. Additionally, the Indiana State Police will provide regular patrols of the Indiana School for the Deaf property and the Indianapolis Metropolitan Police will be adding patrols to the neighborhoods surrounding the lot.

WHERE TO BOARD SHUTTLES

There are two designated shuttle stops adjacent to the lot (see map). The primary stop will be located at the west end of the lot, just inside the Indiana School for the Deaf campus.

LONG-TERM PARKING

If you are staying on grounds during the Fair and will not be using your vehicle, you will still be required to park in the employee lot.

TRANSPORTATION TO AND FROM THE LOT

Two shuttle routes have been developed with multiple shuttles operating on each route. The number of shuttles in service will change throughout the day with more running during peak hours. The goal is to have shuttles leaving from the employee parking lot every 10-15 minutes.

ROUTE A: 5am to 10am (Aug 2-18)
(7am to 8pm on July 29 & 30, 6am-8pm on July 31st & Aug 1)

Once inside the Fairgrounds, this route will travel the inside road around the mile track. It will make 7 stops on the north and south sides of the Fairgrounds (see map).

ROUTE B: 9am to 12:15am

This route will replace Route A after 9am on the first day of the Fair when vehicular traffic is no longer allowed on the interior roads of the grounds. This route will travel the entire Fairgrounds making stops outside the livestock barns, Public Safety, Southwest Pavilion and Gate 1 (see map).

If you need to make special arrangements for drop offs and/or pick ups, please contact Chris Hitch.

GOLF CART PARKING

If you have a golf cart assigned to you during the Fair, you can drive it to and from the employee parking lot each day. Golf cart parking will be available at the lot.

EMERGENCY TRANSPORTATION

If you have an emergency and need immediate transportation to the employee parking lot, please call 317-927-7683. We will dispatch someone to take you to your vehicle.
