Verify both the clinician and client have the proper hardware, software and		
peripheral equipment for your needs		
Check both the clinician's and client's bandwidth		
Environment/facilitators		
Confirm a facilitator or e-helper will be physically present to support the client during the session		
Train your facilitators		
Make sure both the clinician and patient are in comfortable, quiet, private rooms		
with proper lighting		
Check additional environment tips from this guide		
Tools		
Turn evaluation forms into electronic forms (if needed and appropriate)		
Create a list of tools needed during your session at both the clinician's and		
patient's end		
Prepare online reinforcements		
Create scripts and visual aids for the patients to follow during the session		
Formulate and share specific rules and guidelines about when the facilitator/aid		
needs to intervene		
Documentation		
Review the information you need to include in your documentation for telehealth		
evaluation or treatment session		
Review the information you need to include in your documentation during an		
emergency encounter
