### Mr. Bill Bell, Vice President for Human Resources

- Two additional winter recess days approved by President Daniels in thanks and recognition
- Core group of essential employees working through Winter Recess will be provided time off at a later date
- Faculty and staff to receive \$750 appreciation
- Closed out open enrollment with over 12,000 employees enrolled (over 25,000 total with families)
  - 46% of enrollees selected the premier plan highest premium/lowest out of pocket
  - o 30% selected the standard plan
  - 15% selected the limited plan
  - o Benefits provided 52 presentations with over 2,200 attendees
  - o 122 virtual one-on-one sessions
  - o 161 open lab appointments at KPTC
- Open Enrollment survey closed Friday
  - Data will help Healthy Boiler committee and other groups in future planning
