- 63,000 total tests completed on the West Lafayette campus; 1% positivity rate
- Vaccination rate total campus = 88%
  - o Faculty = 94%
  - o Students = 88%
  - Staff = 88%
- Testing surveillance continues for unvaccinated. Unvaccinated staff have been tested
  weekly since classes began, there will be a week of no testing during Thanksgiving break.
  Testing will be back on for 4 weeks with a two-week pause for Christmas break and
  winter recess. Compliance is strong, no one has been moved to a final step for
  progressive discipline. Thanks to all for doing their part to Protect Purdue!

  notification.
- Reviewed 41 citation appeals (May-Sept 2021); granted 5 Appeals, upheld 36 citations
- One Appellant suggest Purdue offer a 'Auto-Renew' option for permits. This has been passed on to Parking Operations.
- Five of the 36 upheld citation appellants are appealing the decision of the Subcommittee, and will be attending our next meeting to justify their appeal inperson (Virtually). FYI, this will be the 3<sup>rd</sup> appeal for each citation (Parking Ops was first, Appeals Subcommittee is second, and third in-person).
- Next meeting (special scheduled) is 11/10, 2pm to review 5 appeals of appeal decisions and six new citation appeals since October meeting
