2019 Letter of Recommendation Service

Pre-Professional Advising offers a letter service for applicants to medical or dental school. We collect recommendation letters and submit a letter packet to the application service. We maintain the letters on file for five years should you need to reapply. If you are applying to medical or dental school in summer 0f 2019 to begin a program in fall 2020, now is the time to sign up for the letter service. To sign up, complete the survey at this link: https://tinyrul.com/2019LetterService. Once you have completed the survey, we will send you a confirmation email that includes a handout to give to your letter writers and instructions you must follow to complete the Letters of Evaluation section of your online application once it opens in the spring.

If you are an applicant to another health field such as physician assistant, physical therapy, occupational therapy, podiatry, optometry, etc. we cannot collect or submit letters of evaluation on your behalf. Follow the directions in your application portal to enter names of letter writers who will

submit their letters directly to the portal. Pre-Professional Advising has created a handout, *Requesting Letters of Evaluation*, to help guide you through the process of requesting letters and a handout you can give to your letter writers, *Pre-Health Letter of Evaluation Writer's Guide*. Professional School Mock Interview

If you have received an invitation to interview with a professional school, you may schedule a mock interview with the Center for Career Opportunities. Follow these steps to schedule the interview:

- 1. Current students must complete a practice interview using Big Interview. https://purdue.biginterview.com/
- 2. Call the CCO at 765-494-3981.
- 3. Ask to schedule a 60-minute professional school mock interview. Provide your name, email address and the interview type (medical school, dental school, etc.)
- 4. Dress in interview attire for the mock interview, unless you are coming directly from the lab where you are not allowed to wear interview attire.
- 5. Check in with the receptionist in room 132, Young Hall.
- 6. Be prepared to answer questions regarding why you want to go into your chosen field, your clinical/healthcare experiences, and meaningful campus or community activities.
