#### *From the President* Year in review 2006-07

— Mike Drayer served as president of the Purdue University Retirees Association during 2006-07. Here is his report to retirees of highlights throughout the year.

What an exciting year we have enjoyed with our involvement in the Association.

The following are the major activities that have had a significant impact on Purdue retirees:

The Association found two worthy PURA award recipients:

■ The Arthur G. Hansen Recognition Award was given to Thomas N. Farris, head of the School of Aeronautics and Astronautics. This award is to recognize an operating unit of the University that has kept retires engaged in major

■ The Betty M. Nelson Special Recognition Award was given to John Beelke, director of Human Resource Services. The Nelson Award is an award to an individual or organization that has provided excellent services to the Association and/or retirees.

Betty Nelson, Roy Johnson, and Christiane Keck, past presidents of PURA, along with current officers Betty Suddarth and me, planned and executed an outstanding 2006 Big Ten Retirees Association Conference held on Purdue's West Lafayette campus. Representatives from the other campuses were most impressed with the conference, especially the programs and campus tour (which included Westwood). Several attendees observed that Purdue has set the bar for others who will be hosting the conference.

Retirees play a major role by volunteering at Purdue and in the community. Also, retirees need to be commended for their generosity in giving to the Campus Campaign for Purdue (\$29,413,342) that began in 2000, and to the United Way Campaign (\$81,024) — an increase of 11 percent over the previous year.

Retirees also had the opportunity to participate in campus and community

tours such as Lawson Computer Science, Biomedical Engineering, and the Schwartz Tennis Center, plus the new Journal and Courier facilities.

In addition, five trips were taken to Indianapolis and Auburn in Indiana, and to Chicago and Springfield in Illinois. The trips were most enjoyable, educational, and entertaining for the more than 114

members and friends who took part.

Two hundred retirees and guests attended the annual kickoff luncheon in August at University Inn. President Martin Jischke gave attendees the "State of University Address" and offered thanks for the contribution retirees continue to make to the University and the Campaign.

The third day-long "Living to 100" conference was held in October with approximately 120 members in attendance. All University retirees received six issues of the *PURA Newsletter*. A special section, entitled "Exploring Senior Living Alternatives" was distributed with January *PURA Newsletter*. This useful tool discussed and analyzed housing and health care choices. It was developed for Purdue retirees and their families by Oscar Hopkins and Richard Nelson.

Again this year, monthly meetings were held at the MCL Cafeteria. Those luncheon programs featured a variety of topics presented by engaging speakers. The sessions were popular and well attended.

The capable Benefits Committee continues to work though problems with communications with United Health Insurance representatives. Much improvement and progress has been made by Martha Chiscon, committee members and Kate LaMar. Special thanks for their efforts and follow-through on these issues.

PURA is in the process of establishing an endowment with the Purdue Foundation using the \$25,000 United

# President Jischke: Thank you and best wishes

— President Martin Jischke spoke to retirees in June at the PURA annual planning meeting and lunch. Here are selections from those remarks.

Thank you very much for inviting me to join you today. Soon I will be joining you formally as a fellow retiree. And I am looking forward to it.

... I appreciate the support you have given Patty and me throughout our years at Purdue. But really it is I who should be standing here applauding all of you.

Everything we have accomplished the past seven years is built upon all that was accomplished at Purdue by those who came before us.

Purdue retirees positioned this university for greatness. And over these seven years, you have played a key role in helping Purdue move to the next level.

What you have done is simply breathtaking. I cannot thank you enough for all you have accomplished for this University.

... There were those who said our Strategic Plans with a vision of preeminence reached too high.

We not only have accomplished the overwhelming majority of our goals, but in many cases we have actually doubled our output in seven short years.

I know of no other university in the nation that has accomplished so much in the past six to seven years.

... Patty and I came to Purdue because we believed in the people of this University. It is the smartest move we've made since our wedding vows.

... Education has made all the difference in my life. And I believe it will make all the difference in the lives of our students as well.

... What have we accomplished? The list is quite impressive.

We said we would build more than three-quarters of a billion dollars in new facilities. We did it. Since our plans began, we have \$786 million worth of new facilities completed, under construction or in the planning stage.

At a time when universities around the nation struggled just to stay even, we said we would add new faculty. We did it. To date, we have added 265 faculty, and we will reach our goal of 300 by next fall. We said we would step up efforts to recruit and keep top faculty for our students and state. We did it. We have doubled the number of endowed professorships.

We said we would increase our research program. We did it. We doubled it.

We said we would increase student financial aid and scholarships. We did it. We have increased it 66 percent in six years.

We said we would increase diversity. We did it. Diversity is at record levels. The number of African-Americans in our freshman class this fall is 30.4 percent higher than five years ago.

We said we would increase engagement with our state. We did it. Purdue is now perceived around Indiana and the nation as a leader in university engagement, especially when it comes to education and economic development.

We said we would launch interdisciplinary, cutting-edge research that would impact our state. We did it. Our Discovery Park has grown from an idea six years ago to a \$350 million research and learning complex that has changed the culture of our university and opened incredible potential for our state.

... We are receiving record numbers of applications for admissions. We are enrolling the academically best-prepared classes in our history. Study abroad and internships are up. Our graduation rate at Purdue is at its highest point in history.

A Purdue education has never been better. A Purdue diploma has never been worth more.

We told people six years ago that we would transform Purdue into an even more world-renowned university. We did it, and more.

In late March we had one of the most exciting announcements in the history of Purdue. The Alfred Mann Foundation for Biomedical Engineering, in California, is funding an Alfred Mann Institute at Purdue University with an incredible endowment of \$100 million!

This is the largest single endowment in the history of Purdue. This institute will enable the commercialization of innovative biomedical technologies that improve human health and life.

... As we look to the future, Purdue already has begun discussing our next

strategic plans. I have been traveling the state asking community leaders what they want from Purdue in the next five to six years.

We are receiving huge support for what we have accomplished. People are thanking us for what we have done. And they are asking for more of the same.

This summer, a new and excellent president, France Córdova, will be at Purdue.

There will be new strategic plans.

There are three issues that I believe the university will continue to pursue and keep at the forefront throughout this effort.

First, increasing the research initiative even further.

Second, the continued importance of fundraising.

And third, the continued focus on improving Purdue's learning environment.

... I arrived here believing that teaching and learning are job one at Purdue. I feel the same today.

Everything we have done has ultimately been focused on our learning environment.

Thank you for your partnership in all that we have accomplished.

Of all the things I've done or could do, the Purdue presidency has been the most rewarding.

... Thanks to you all. All hail from old Purdue!

# Retirees again ready to help set pace for United Way

Purdue retirees will be pacesetters again this year for the annual Purdue and community United Way campaigns.

As pacesetters, retirees will conduct their portion of the campaign before the regular campaign gets under way at the West Lafayette campus.

The retirees and Vanguard campaign will kick off Aug. 1. Retirees should get a

mailing from Purdue United Way on Aug. 2 or Aug. 3.

The retirees' goal for this year will be \$84,000. Last year, retirees contributed their most ever to United Way with \$83,274.

United Way Vanguards are those individuals who give \$1,000 or more to the United Way campaign to help offset administrative expenses. Purdue has 260 Vanguards, the most in the community.

Purdue plans to complement United Way's 2007 community campaign theme of "Your Choice Matters" with the Purdue theme "We Matter." The overall Purdue goal this year will be \$720,000.

Chair for the retirees portion of the United Way campaign is Betty Suddarth. Vice chair is Scott Rumble.

#### News from your PURA Benefits Committee

The Benefits Committee of the Purdue University Retirees Association offers this important information:

1. A reminder that PURcare has a \$300 deductible on the medical plan. That means you will be billed by your provider for that portion of the approved Medicare cost that Medicare does not pay until you have fulfilled the deductible. After you fulfill the deductible, your approved Medicare costs will be covered at 100 percent.

2. Medicare "Explanation of Benefits" reports are being sent quarterly rather than monthly as in the past.

3. If you have a well-care (physical exam or hearing test) cost from 2006 that has not yet been reimbursed, contact Kate LaMar at (765) 494-1694 to help you obtain the reimbursement. The same should be done for unreimbursed international medical costs incurred while traveling outside the United States.

4. UnitedHealth representatives occasionally visit the Purdue campus. For information, call Michele Salla at (765) 494-1779.

5. You should be receiving correct prescription "Explanation of Benefits" (EOB) communications each month.


6. There is no deductible for prescription drugs. You pay a co-insurance of 50 percent at a local pharmacy or 45 percent through mail order.

7. You should be receiving updated materials from UnitedHealth Rx about prescription drug coverage.

8. PURcare prescription drug coverage uses an open formulary, which means it covers more prescription drugs than any private Part D plan. Your coverage also does not have a gap in coverage and your co-insurance, after you have reached outof-pocket expenditures of \$3,850, will be 0 percent. In addition there are very few prior approval requirements and no step therapy requirements. Some drugs available to you are not available on Part D private plans.

9. In 2006, just under 5 percent of our PURcare members reached the catastrophic coverage for prescription drugs. At that point, their drugs were covered at 100 percent for the remainder of the year. Another 40 percent of our PURcare members would have reached the gap in coverage with a private Part D plan and would have been responsible for 100 percent of their drug costs until they reached an out-of-pocket expenditure of \$3,600, at which time they would have to pay 3 percent to 5 percent of their drug costs for the remainder of the year. No private Part D plan can match our coverage at any price.

10. If you are approached to sign up for a Medical Advantage or other medical or prescription drug plan, please contact Kate LaMar at the above number to compare plans before you sign anything. Signing up for another plan will disenroll you from PURcare.
