## Tour of Birck Center set for May 31

An in-depth tour of the Birck Nanotechnology Center has been scheduled for May 31. PURA members will gather at 4 p.m. at the Burton D. Morgan Center for Entrepreneurship. The schedule will be as follows:

- 4 4:15 p.m. A brief overview of Discovery Park by George Adams, special projects manager at Discovery Park.
- 4:15-5 p.m. Tour of Birck conducted by Adams.
- 5 5:30 p.m. Reception in the Birck Nanotechnology Center Atrium.

Note. There is a considerable amount of walking during the tour. Elevators will accommodate those who do not wish to walk the stairs.

Parking. The Burton D. Morgan Center is at the southwest corner of State Street and Intramural Drive; the main entrance is on the east side of the building. By 4 p.m. on May 31, parking is expected to be available on street and in the lot at the corner of Gates and Nimitz, within a reasonable walking distance of Morgan. Drive south on Intramural, turn right on Nimitz, and the lot will be on your right. Alternatively, you may wish to park in the gravel lot just west of Fowler House, then cross State Street at the light at Intramural Drive. Morgan will then be immediately on your right.

#### News from your benefits committee

The Benefits Committee of the Purdue University Retirees Association offers this important information:

- 1. A reminder that PURcare has a \$300 deductible on the medical plan. That means you will be billed by your provider for that portion of the approved Medicare cost that Medicare does not pay until you have fulfilled the deductible. After you fulfill the deductible, your approved Medicare costs will be covered at 100 percent.
- 2. Medicare "Explanation of Benefits" reports are being sent quarterly rather than monthly as in the past.
- 3. If you have a well-care (physical exam or hearing test) cost from 2006 that has not yet been reimbursed, contact Kate LaMar at (765) 494-1694 to help you obtain the reimbursement. The same should be done for unreimbursed international medical costs incurred while traveling outside the United States.
- 4. UnitedHealth representatives will visit Purdue on June 13 and 14. To make an appointment to resolve a medical or prescription issue, call Michele Salla at (765) 494-1779.
- 5. You should be receiving correct prescription "Explanation of Benefits" (EOB) communications each month.
- 6. There is no deductible for prescription drugs. You pay a co-insurance of 50 percent at a local pharmacy or 45 percent through mail order.
- 7. You should be receiving updated materials from UnitedHealth Rx about prescription drug coverage.
- 8. PURcare prescription drug coverage uses an open formulary, which means it covers more prescription drugs than any

private Part D plan. Your coverage also does not have a gap in coverage and your co-insurance, after you have reached out-of-pocket expenditures of \$3,850, will be 0 percent. In addition there are very few prior approval requirements and no step therapy requirements. Some drugs available to you are not available on Part D private plans.

9. In 2006, just under 5 percent of our PURcare members reached the catastrophic coverage for prescription drugs. At that point, their drugs were covered at 100 percent for the remainder of the year. Another 40 percent of our PURcare members would have reached the gap in coverage with a private Part D plan and would have been responsible for 100 percent of their drug costs until they reached an out-of-pocket expenditure of \$3,600, at which time they would have to pay 3 percent to 5 percent of their drug costs for the remainder of the year. No private Part D plan can match our coverage at any price.

10. If you are approached to sign up for a Medical Advantage or other medical or prescription drug plan, please contact Kate LaMar at the above number to compare plans before you sign anything. Signing up for another plan will disenroll you from PURcare.

#### 1. FRENCH LICK AND WEST BADEN. 8 a.m. Sept. 18 - 5 p.m. Sept. 19.

The Southern Indiana resorts offer luxurious guest rooms, gaming in the casino, relaxing in the spa, three golf courses, and one of the world's largest interior domes. Guests will spend the night Sept. 18 in the French Lick Hotel. The trip cost is \$205 each for those sharing a room and \$288 for those with a single room. The cost includes bus transportation, hotel room, Tuesday dinner and Wednesday breakfast in the Grand Colonnade Cafe, and a \$10 gaming pass. Participants will be responsible for lunch both days and any golf, spa, mineral bath or casino participation above the \$10 pass.

2. JASPER-PULASKI WILDLIFE REFUGE. 2-8:30 p.m. Oct. 23. Cost is \$45 per person and includes admission to the Whistle Stop Railroad Museum and dinner at the Whistle Stop Restaurant.

The Whistle Stop Museum contains railroad artifacts, in particular those from the Monon Railroad. The tour will visit Jasper-Pulaski immediately before dusk, when the Sandhill Cranes are gathering in an open meadow. The cranes arrive in flights of 10 to 20 birds and come from all directions.

3. ROSE-HULMAN AND CLABBER GIRL MUSEUM, TERRE HAUTE. 8 a.m.-8 p.m. Nov. 14. Cost is \$80 and includes lunch at the Clabber Girl Museum and dinner at the Attica Hotel.

Participants will see only a few of the Hulman family activities on this trip. The Rose-Hulman Institute is a renowned school of engineering. The trip includes a tour of the buildings with an emphasis on the displays of artwork. The Clabber Girl Museum portrays the Hulman/Clabber Girl story. Clabber Girl continues to manufacture products for the food industry. There will be a cooking demonstration and lunch will be provided. The return trip will feature a prime rib dinner at the Attica Hotel.
