- Speaker: Mark Kebert, Director of Risk Management Purdue
- Mark Kebert is Executive Director and Chief Risk Officer for Purdue University and its 40 affiliated support entities which include Purdue Research Foundation, Purdue Alumni Foundation, Purdue for Life Foundation, Mc Clure Park, and Purdue PARI. He is a career risk professional who rose through the risk financing industry in several large insurance companies including Farmers Insurance Group, The American Family Group and others leading him into higher-education risk leadership. Kebert has been a visible leader for Purdue's risk strategy for the past 24 years advising the Board of Trustees as well as executive leadership. He is regularly quoted in industry outlets about emerging risks (including cyber and drone technologies) and has helped Purdue's Office of Risk Management to earn national recognition for innovative programs.
- Topic: Managing Institutional Risk and the Basic Application of the Risk Assessment Mindset
- Purdue's Office of Risk Management identifies and evaluates risks to which the Purdue community
 is exposed and develops efficient ways to manage and finance those risks. From research
 laboratories, to sporting events, campus activities, student organization activities and even


What to do if you are having problems receiving PURA emails

<u>The December Monthly Meeting Program</u> Rebuilding Trust in Higher Education: The Opportunity for Land-Grant Universities

Our PURA program in December featured former dean, provost, and now Trustee Chair in Teaching and Learning Excellence Jay Akridge. 51 in-person attendees and 39 via Zoom were treated to this very interesting topic and Jay's insight. Using charts, graphs and statistics, Jay traced the sources of how trust in college has eroded. The misperception of debt is one and the value or rate of return on a degree is another, among many, but statistics indicate otherwise. "These various "disconnects" are frustrating but can't be ignored," he told us. His Blueprint for action include: Establish Relevance (Link Research, Extension, Teaching), Bring Stakeholders In (Creative, Intentional Listening), Reframe Success (Traditional Metrics Won't Hold), Be Authentic Storytellers (Communicate on Stakeholders Terms), Elevate the Teaching Mission, Rethink Access and Completion (Simple Message of College Benefits), Develop a Career Ready Focus (Deep Look at What's Needed in Work World) and Residential Must Be Experiential (Why Come to a Physical Campus). His weekly feature "Finding Equilibrium" on Substack along with Dean of Business David Hummels expands on these themes and much more. New Year Brings Changes to Social Security, Medicare, and PURA Insurance Plans

The arrival of 2026 brings changes that will impact each of us. We should each be aware of the following:

For Social Security and Medicare Recipients

- Your monthly Social Security benefit will increase 2.8% in 2026 because of a rise in the cost of living.
- The standard Medicare premium increases to \$202.90. You may be required to pay an additional Medicare premium based on your 2024 income tax return.

For PURcare Participants

- The PURcare (Senior Supp plus Part D prescription plan) premium increases to \$366.87/member.
- PURcare coverage changes are:
 - A. The PURcare medical/hospital deductible increases from \$300 to \$500.
 - B. The PURcare prescription drug deductible increases from \$0 to \$300.
 - C. The PURcare prescription drug co-pays for 2026 will be:

Tier 1 50% up to \$15 max.
Tier 2 50% up to \$47 max.
Tier 3 50% up to \$100 max.
Tier 4 50% up to \$100 max.

 Members will receive new ID cards from UnitedHealthcare (UHC)-Senior Supplement and Medicare Rx Groups.

For PURA Group Medicare Advantage Participants

- The Group Medicare Advantage PPO for 2026 will have a decreased premium. The premium will be \$190.45.
- Medicare Advantage PPO coverage changes are:
 - A. The medical/hospital Maximum Out- of- Pocket increases from \$3,400 to \$5,000.
 - B. The medical/hospital deductible increases from \$0 to \$500.
 - C. Skilled Nursing Facility days 1-20: Decreased per day copay from \$20 to \$10.

- D. Inpatient Mental Health/Substance Abuse in a Psychiatric Hospital: Decreased copay from \$200 to \$150.
- E. Medicare-covered Chiropractic Visit: Decreased coinsurance from 50% to 40%.
- F. The prescription drug deductible increases from \$0 to \$300.
- G. Prescription drug co-pays for 2026 at a retail pharmacy will be:

Tier 1 \$4 Tier 2 \$28 Tier 3 \$58 Tier 4 29%

 Members will receive a new ID card from UnitedHealthcare (UHC)-UHC Group Medicare Advantage PPO.
