

University Senate Newsletter Second Meeting, 17 October 2022, Virtual

Senate Chair's Remarks:

Chair Brady urged Senators to think about how to best use the expertise they have access to on campus in bringing forward proposals. She offered congratulations to our seven colleagues who received named/distinguished appointments at the 7 October Board of Trustees meeting. She underscored the importance of supporting students, faculty, and staff who have been impacted by the tragic event that took place in in McCutcheon Hall. She invoked the mid-semester stress that all faculty, staff, and advisors feel in working with students as they navigate their midterms and begin work on spring course selection at the same time. As a gesture of encouragement, she played a recitation of a version of "Success" / "To Laugh Often and Much" (Bessie A. Stanley, 1906; often attributed to Emerson).

> To laugh often and much; to win the respect of intelligent people and the affection of children; to earn the appreciation of honest critics and endure the betrayal of false friends; to appreciate beauty, to find the best in others; to leave the world a bit better, whether by a healthy child, a garden patch, or a redeemed social condition; to know that even one life has breathed easier because you lived. This is to have succeeded.

Purdue President's Remarks:

President Daniels shared some results of Purdue's report on campus free speech. The survey of all undergraduate students at all Indiana public universities was conducted by ICHE in compliance with Indiana House Bill 1549 (passed in 2022). Purdue West Lafayette's ca. 11,000 (34%) responses represent 60% of the total responses collected statewide across all seven public universities. Ideological breakdowns by academic units were provided and are available on the Senate website. In general, most (81%) Purdue students believe they are free to express themselves on campus and that Purdue values free speech. On all points, Purdue scored higher in these measures than other Indiana Universities.

There are some opportunities for improvement in addressing the perception that liberal views are more welcome in the classroom, in exposing students to scholarly ideas from a diversity of viewpoints, and in teaching students about appropriate ways to respond to speech.

Purdue President's Remarks (continued):

Nearly half of students felt that shouting down speakers or trying to prevent them from speaking was "always" or "sometimes acceptable," and 19% of students indicated that using violence to "stop a speech, protest, or rally" might be acceptable, whereas President Daniels argued the answer should have been "never acceptable." This was addressed in the Fall 2022 Boiler Gold Rush. Faculty who want more information on the results or dataset are welcome to inquire for it.
