Fourth Meeting, 23 January 2023, Virtual

Senate Chair's Remarks:

Chair Colleen Brady provided a brief update from the December Board of Trustees meeting. She congratulated our four colleagues who were ratified in their named appointments. She reminded the community of the recent renaming of several buildings and relocation of programs (e.g., Recitation Hall is now Schleman Hall of Student Services), and urged everyone to remember to check their maps in the coming weeks as we adjust to the changes. She also relayed that the Trustees had expressed recognition and appreciation for the many contributions of President Daniels and Provost Akridge to Purdue's achievements.

Chair Brady stated that she wished to speak to the Senate about change: often, we want things to be different, but not necessarily to do things differently. Purdue has an opportunity in the coming months to make changes in positive ways. She highlighted the Senate report from the Purdue Student Government, and the many ways they have worked this year to institute positive changes to support our students. She noted that we have a chance to demonstrate our belief in the importance of equity and inclusion through the high number of deanship and faculty searches moving forward this semester. The decisions our community makes now will have an impact on what Purdue will look like for the next decade.

Chair Brady added that Senators have been elected to represent their units, and are thus in a leadership role within their units. The questions before the Senate were, then, how can we use our roles as leaders to help define what Purdue will be in the future? How can we use our committees to create positive change and keep Purdue moving forward? Are we serving *all* of our constituents—our students, colleagues, and community and industry partners? And finally, most importantly, can we take a look at what we have inherited as the "Purdue Way" of doing things, and make sure it is still the best way to support Purdue's 21^{st} -century mission?

Purdue President's Remarks:

President Mung Chiang greeted the Senate, and recalled attending faculty meetings as an assistant professor, where, in learning the ropes, he learned about the importance of the conversations that take place in shared governance meetings. He thanked the Senate for the opportunity to be with them and to serve with them. He then asked to highlight three issues:

- He reminded the community that on day one of the Spring 2023 semester, his administration <u>had announced</u> the creation of the Action Council on Student Housing and Wellbeing (SHW) to look into graduate and undergraduate students' housing, health, and mental needs.
- 2) Also on 9 January, Provost Wolfe, EVPR Plaut, and CFO Ruhl announced six initial steps to reward and recognize faculty excellence, including a dedicated Faculty Recognition Office to advance external nominations and awards. In the future, these and other related steps will constitute a new Giant Leap.

Purdue President's Remarks (continued):

3) He invited the community to participate in the many scholarly events happening on campus, including the first of the 2023 <u>Presidential Lecture Series</u>, featuring 2021 Nobel Prize laureate David MacMillan, which takes place on 13 February (just before Valentine's Day, for those who see the romance in chemistry).

President Chiang introduced Provost Patrick Wolfe. Provost Wolfe echoed President Chiang's sentiments and expressed excitement for the new initiatives they were undertaking to improve the success of faculty and students alike. He noted that he was very interested in working with and learning from faculty, particularly with respect to major issues in Teaching and Learning 2.0. For example, he asked, how might the judicious use of AI, Chat GPT, et al. help us to become and/or remain national leaders in these important areas?

Administrative <u>responses</u> to pre-submitted questions were posted to the Senate website. It was also stated during Question Time that the increased demand for on-campus electric vehicle charging stations is being studied.
