

What is an eStatement in TouchNet?

eStatements are a snap shot in time of your billing charges based on the day it is created. You have convenient access to them from any device with an internet connection 24/7. A student may authorize others, such as parents, guardians, or a spouse, to view billing information and/or pay bills on his or her behalf.

Note: the eStatements can only be viewed by the student or Authorized Users

What is a 1098T?

Families filing a U.S. tax return may be eligible for educational tax credits when claiming their Purdue student as a dependent. The IRS Form 1098-T is the form provided to help file for these tax credits.


How do I view and pay my eStatement in TouchNet or view/print my 1098-T?


Using your Purdue career account user name and BoilerKey, login to myPurdue at https://mypurdue.purdue.edu.

The TouchNet payment portal will open. You can view/pay your invoice from here and you can access your 1098T to view/print from this screen.





- Under the section '1098-T Statement,' click on the 'View' link of the year you want to view and print.
- Make sure you are using the most recent version of Internet Explorer and have your 'pop-up blocker' turned off.



- This will open a PDF pop-up with a viewable and printable 1098-T.
