Dear Governor Holcomb:

At its meeting on December 6, 2019, the Purdue University Board of Trustees approved the planning, financing, construction and award of construction contracts for the Bands and Orchestras Building on the Purdue West Lafayette campus.

This project includes the construction of a new, 37,500 GSF facility consisting of shared academic/rehearsal spaces, practice and instruction rooms and administrative offices for faculty and staff. The new facility will be located at the corner of Third and North Russell Streets.

The new facility will consolidate more than 30 ensembles, percussion, concert bands and jazz bands into one building.

The estimated total cost of this project is \$20,000,000 and will be funded with Gift Funds.

Subject to review by the Commission for Higher Education and recommendation by the State Budget Committee and the Budget Agency, we request your approval to proceed with this project. Attached are the completed forms that the Commission has prescribed for its review of such projects. We will be happy to answer any questions you or your staff may have or to provide any additional information that is needed.
