


CHANCELLOR'S REPORT

FY23 Purdue Global Results

Metric Results:

- Growth in census vs. FY 2022 driven by improved start rate and retention.
- Over 11,700 graduates (up 3%), with continued focus on persistence.

Financial Result:

- FY23 net revenue slightly higher compared to prior year.
- FY23 operating income, prior to accruals for service fees, similar to FY22.
- Projected modest loss for FY23 on full accrual basis as available cash was sufficient to nearly fully fund the service fees.
- FY22 resulted in a \$10M accrual basis surplus.
